Marco Becht

Goldschmidt Chair Professor at the Solvay Brussels School for Economics and Management at Université libre de Bruxelles where he teaches master courses on corporate governance and stewardship and responsible capitalism. Becht is also a Founder Member, a Fellow and the Executive Director of ECGI, an international research network. Becht has been a Visiting Professor at the Saïd Business School, University of Oxford, Stanford Law School, Columbia Law School and the University of St. Gallen. His research is at the intersection of corporate law and finance and has appeared in peerreviewed journals like the Review of Financial Studies and the Journal of Law of Economics.

Bernhard Brüne

Professor Brüne studied biochemistry at the University of Tübingen and obtained his doctorate at the University of Constance. After stays abroad in the US (GlaxoSmithKline, 2 years) and in Sweden (Karolinska Institute, 1 year), he completed his habilitation in Constance in 1993. After professor ships in Erlangen/Nuremberg and Kaiserslautern, he has headed the Institute of Biochemistry I at the Faculty of Medicine, Goethe University Frankfurt since 2004. His research aims at understanding mechanisms of innate immunity, while focusing on oxygen deficiency and lipid signaling. In addition to curricular teaching for human and dental physicians, he participates in graduate education and the Molecular Medicine program.

From 2009 to 2021, he directed the CRC 815 (Redox Regulation) and since 2017, he is the spokesperson of the DFG-funded Research Training Group 2336 (Resolution of Inflammation).

In 2020/2021 he was Dean of Research, and before that Dean of Preclinical Studies at the Faculty of Medicine for 7 years. Prof. Brüne is member of the GRADE board, a reviewer for international research organizations and journals, including EditorinChief of Biological Chemistry from 2012 to 2020. He has served or is serving on the boards of foundations and scientific advisory boards of various research institutions. His research is continuously supported by DFG, other thirdparty funding agencies, industry, and various awards. He has published numerous scientific papers, acquired patents, and is a member of national/ international professional societies.

As Vice President, he pursues the goal of establishing optimal conditions for young scientists and research and aims at positioning GoetheUniversity among the top universities in Germany.

Hannah Helmke

Hannah Helmke is Co-Founder and CEO of the Frankfurt-based climate tech company right. based on science (right°). With right°, she strives to integrate a simple °C number as a decisive KPI with science-based metrics to help companies meet the challenging targets set out by the Paris Climate Agreement and decouple their economic growth from CO2 emissions. Her focus on economic activity in a world affected by climate change was the result of combining both of her academic disciplines: psychology and international business. She is guided by a strong conviction that a science-based approach is the best way to manage the emotionally charged field of corporate climate strategy.

Before founding right[°], Hannah Helmke worked for the IT service provider Bridging IT and for the Deutsche Post DHL Group. There, she explored the potential of digitalization as a lever to reach sustainability targets and worked on introducing science-based targets as reporting instruments.

Under Hannah Helmke's leadership, right^o has received the prestigious Next Economy Award 2020. She herself was awarded the Digital Female Leader Award 2020 in the category Sustainability as well as the Female Founders Award of AmCham Germany in 2021.

Rebecca Peters

University of Tübingen, Environmental Systems Analysis

Rebecca Peters (M. Sc. Geoecology) is a doctoral researcher at the University of Tübingen, and a freelance consultant for climate change adaptation. In her research position, she works on identifying sustainable pathways for a renewable energy transition in African countries to mitigate climate change. Ms Peters investigates national drivers and challenges that determine the continental potential for leapfrogging an environmentally sustainable transition towards entirely renewable energy-based electricity systems.

Towards this aim, she created RePP Africa, a spatially explicit and open-access database on existing and proposed hydro-, solar, and wind power plants to support stakeholders from science, (non-)governmental organizations, consulting, and industry. Based on this dataset, she investigates how a renewable energy mix could relieve the dam-building pressure on rivers in Africa to guarantee long-term river functioning. Ms Peters will present an overview of existing and proposed hydro-, solar, and wind power plants, discuss possibilities and challenges for a transition towards renewable energy-based electricity access, and highlight why it is crucial to consider environmental impacts in renewable power plant planning

Wolfgang Rams

Professor Rams is co-founder and CFO of Africa GreenTec as well as heading Germany. He is a serial entrepreneur, an investor and business angel. In 2016, he invested in Africa GreenTec, was chairman of the supervisory board for 3 years and is now a board member since 3 years. He has been teaching entrepreneurship and innovation management for almost 10 years, but gave up this job to focus on his board position at Africa GreenTec. Africa GreenTec delivers electricity and sustainable systems solutions to the most remote and inaccessible places in the Global South. Its ImpactSites measurably empower people to achieve more self-determination and growth.

Before joining Africa GreenTec Wolfgang founded in 2006 the consulting company Consmart GmbH in Duesseldorf where he was active as a consultant for innovation management and entrepreneurship, founded several startups, and became a Business Angel. Prior to that, he worked 11 years for Deutsche Telekom where he was Director of Strategy and Business Development at T-Mobile Poland in Warsaw and held a position as a senior investment manager at T-Venture.

Klement Tockner is the Director General of the Senckenberg Gesellschaft für Naturforschung and a Professor of Ecosystem Sciences at Goethe University, Frankfurt am Main (since 2021). He served as President of the Austrian Science Fund FWF (2016– 2020), Professor of Aquatic Ecology at the Free University of Berlin (2007–2020), and Director of the Leibniz Institute for Freshwater Ecology and Inland Fisheries (IGB), Berlin (2007–2016). He received his PhD from the University of Vienna (1993) and a titular professorship at ETH Zurich (2005).

Klement Tockner is an internationally renowned freshwater scientist, particularly in the research fields of biodiversity, ecosystem science, and environmental management. He was editor-in-chief of the journal Aquatic Sciences (2005–2014) and is a technical editor of the journal Ecosystems. He has published about 250 scientific papers, including more than 180 ISI articles. In 2009, he published a comprehensive book on European rivers (Rivers of Europe, Elsevier; 2nd edition in 2022).

Klement Tockner successfully led large inter- and transdisciplinary projects such as the "BioFresh" project funded by the European Commission. He is a member of several scientific committees and advisory boards, including the National Institute of Environmental Studies, Japan (NIES), and the Biology Centre, Czech Republic. He is an elected member of the Austrian Academy of Sciences, the German Academy of Sciences Leopoldina - National Academy of Sciences, and the Mainz Academy of Sciences and Literature.
